## Title: PROCUREMENT OF EQUIPMENT, FURNITURE AND FITTINGS FOR THIRTY (30) BILINGUAL EDUCATION BOARDING SCHOOLS IN THE NINE (9) PARTICIPATING STATES

1. The Federal Government of Nigeria has received financing for an amount of US\$ 109.18 million from the Islamic Development Bank (IsDB) towards the cost of Bilingual Education Project, and intends to apply part of the proceeds towards payments under the contracts for the Procurement of Equipment, Furniture and Fittings for the thirty (30) Bilingual Education Boarding Schools in the Nine (9) participating states.

2. The Universal Basic Education Commission now invites sealed bids from eligible bidders for not more than **One (1) lot** for the Procurement of Equipment, Furniture and Fittings for the thirty (30) Bilingual Education Boarding Schools in the Nine (9) participating states.

Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **9<sup>th</sup> November, 2023, by 12.00 noon**. However, a **soft copy of the Financial Bid in an excel format shall be submitted in a flash drive** along with the hard copies of both Technical and Financial Bids.
